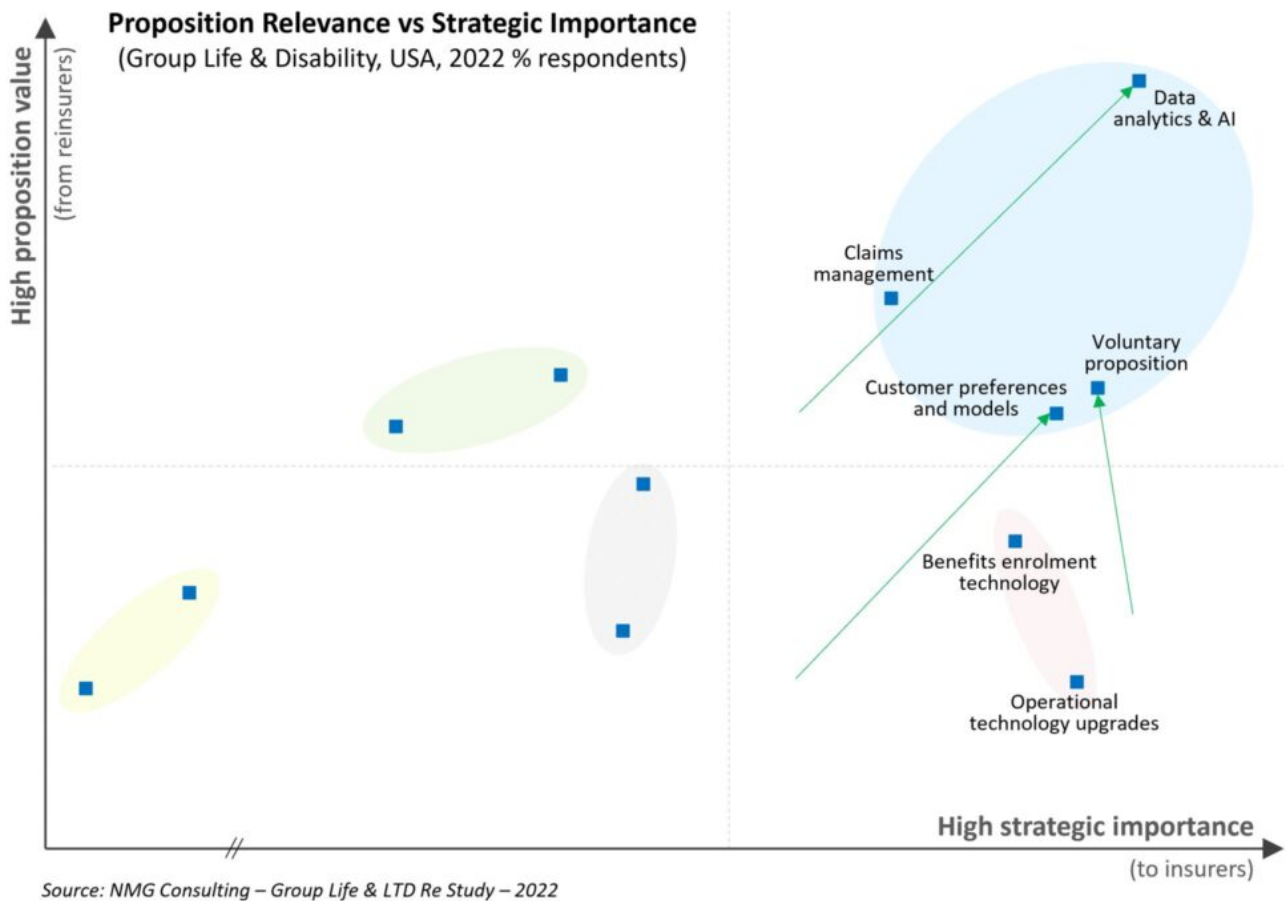
Insurers' strategic priorities often speak to the challenges and opportunities in any given segment. In the case of the US Group Life & Disability:

- Modernising core operating technology (including benefit enrollment platforms) continues to carry high strategic importance
- That group platforms now dominate (~80%) new sales of Voluntary Benefits has made it a leading priority for group insurers
- The extent of the ramp-up in importance of data analytics capabilities highlighted a level of urgency as well as greater relevance
- A deepened understanding of customers, more usually associated with retail segments, is also gaining traction

Reinsurers seemingly have more ways to support group insurers than just a few years ago, with the value of reinsurance propositions lifting sharply across many key areas.
